
AND UPON CONSIDERING the terms agreed between the parties and set out herein;


AND BY CONSENT it is ordered that:



2. The Applicant is authorized to take (i) such steps as may be necessary to procure the removal of any restriction placed on the titles of Block: 42 1894A; Parcels 1164 and 1149 to forthwith allow the closing of their intended sale; and(ii) such other steps as are required by paragraph 7 of the Order dated 30 August 2011
3. The net proceeds of sale are to be paid into the Designated Account from which the Third Respondent will be permitted to meet its ordinary business expenses and legal fees.
